Successfully Guiding a Children's Hospital through a Myriad of Complex Legal Issues

Since 2012, Buchanan has served as legal counsel to a well-known children's hospital with two hospitals and locations in four states. During that time, we have provided counsel on credentialing issues, medical staff matters, HIPAA and privacy issues, and provided advice regarding regulatory and contractual issues related to telehealth programs with local schools. We have also counseled on various transactional matters, including the sale of a retail pharmacy, lease of space, and regulatory issues regarding the 340B program; a joint venture to create a women and children's hospital; and the acquisition of pediatric physician practices. Other matters on which we have counseled this client have included review of a series of agreements on the use of a new drug to treat pediatric cancers; counseling on a product pricing agreement and consignment agreement with a major pharmaceutical company; a government investigation of a compounding pharmacy; counseling on regulatory considerations associated with the purchase of equipment for clinical research; and reviewing purchase agreements with medical device companies.
